to the Sales Office for registration (a person completing the aforesaid procedures is referred to as a "Registrant") and specify the residential property(ies) that the Registrant wishes to purchase. Subject to paragraph 2 below, upon the expiry of the Attendance Registration Period, a Registrant will have priority in purchasing the residential property(ies) that he/she has expressed interest to purchase.

- 2. If during the Attendance Registration Period, more than one Registrant express interest to purchase the same residential property, balloting will be used to determine the order of priority in which each of such Registrants may purchase that residential property.
